4 FIRST-AID MEASURES

INHALATION

Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.

INGESTION

NEVER MAKE AN UNCONSCIOUS PERSON VOMIT OR DRINK FLUIDS! Provide rest, warmth and fresh air. Get medical attention immediately! Drink plenty of water.

SKIN CONTACT

Remove affected person from source of contamination. Get medical attention promptly if symptoms occur after washing. Promptly wash contaminated skin with soap or mild detergent and water. Promptly remove clothing if soaked through and wash as above.

EYE CONTACT

Remove victim immediately from source of exposure. Make sure to remove any contact lenses from the eyes before rinsing. Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention.

5 FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA

Use fire-extinguishing media appropriate for surrounding materials. Foam, carbon dioxide or dry powder. Do not use water jet as an extinguisher, as this will spread the fire.

6 ACCIDENTAL RELEASE MEASURES

PERSONAL PRECAUTIONS

PROCESS CONDITIONS

Provide eyewash station.

ENGINEERING MEASURES

Provide adequate general and local exhaust ventilation.

RESPIRATORY EQUIPMENT

If ventilation is insufficient, suitable respiratory protection must be provided. Use chemical cartridge protection with appropriate cartridge.

HAND PROTECTION

Nitrile gloves are recommended, but be aware that the liquid may penetrate the gloves. Frequent change is advisable. Barrier cream applied before work may make it easier to clean the skin after exposure, but does not prevent absorption through the skin.

EYE PROTECTION

Wear tight-fitting goggles or face shield.

OTHER PROTECTION

Wear appropriate clothing to prevent any possibility of skin contact.

HYGIENE MEASURES

Wash at the end of each work shift and before eating, smoking and using the toilet. Wash promptly with soap & water if skin becomes contaminated. Promptly remove any clothing that becomes contaminated. When using do not eat, drink or smoke.
