4 FIRST-AID MEASURES

GENERAL INFORMATION

NOTE! Effects may be delayed. Keep affected person under observation.

INHALATION

Extinguish with foam, carbon dioxide or dry powder. Do not use water as an extinguisher.

6 ACCIDENTAL RELEASE MEASURES

PERSONAL PRECAUTIONS

PROCESS CONDITIONS

Provide eyewash station.

ENGINEERING MEASURES

Provide adequate general and local exhaust ventilation.

RESPIRATORY EQUIPMENT

If ventilation is insufficient, suitable respiratory protection must be provided. Use chemical cartridge protection with appropriate cartridge.

HAND PROTECTION

Nitrile gloves are recommended, but be aware that the liquid may penetrate the gloves. Frequent change is advisable. Barrier cream applied before work may make it easier to clean the skin after exposure, but does not prevent absorption through the skin.

EYE PROTECTION

Wear tight-fitting goggles or face shield.

OTHER PROTECTION

Wear appropriate clothing to prevent any possibility of skin contact.
